**Special Repeat Examinations (Even-Semester), July 2017**

1. Students who have arrears in Even-Semester courses (other than due to shortage of attendance) can apply for Special Repeat Examinations (Even-Semester), July 2017. That is, students of Fourth year / Third year / Second year / First year can register for their arrear courses of Even-semester programs. If the student has failed due to attendance shortage, he/she should not apply for the Special Repeat Examinations (Even-Semester), July 2017.
2. The students are permitted to register in the Special Repeat Examinations (Even-Semester) for the course(s) in which he/she has failed, i.e. students who have passed the course(s) already are not permitted to register for the same.
3. Download the application for the Special Repeat Examinations (Even-Semester), July 2017 from TNNLS website and submit to the Examination Section along with DD / UCO Bank Challan for Rs.1,000/- per course. (Demand draft drawn in favour of "The Registrar, TNNLS" payable at Tiruchirappalli)
4. The last date for receipt of filled-in application along with DD / UCO Bank Challan is 27.07.2017. The Examination Section will not be held responsible for the delay of applications.
5. The Special Repeat Examinations (Even-Semester) for the academic year 2016-2017 is scheduled to commence from 29.07.2017. The detailed schedule will be announced later and uploaded in TNNLS website.
6. Examination fees once paid will not be refunded under any circumstances or adjusted for future examinations.

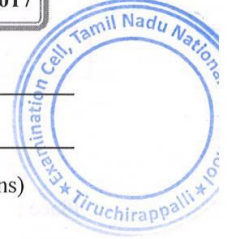
